I have the honour to state that Govt. have been pleased to take  
over the K.C.Das Com.College College, P.O. Guwahati  
Dist. Kamrup under deficit system of G.I.A.  
w.e.f. 25.3.98 vide Govt. Notification No. B(2)H.553/96/85, dtd.  
21.8.98 and Govt. letter No. B(2)H.553/96/86, dtd. 17.9.98. The  
appointment of incumbents holding the post of lecturers in the  
defferent Departments fulfilling the present U.G.C. norms for  
appointment as lecturers as per Govt. of India's letter No.  
F.1-21/87/UI, dtd. 17.6.87 their letter of even No. dtd. 22.7.88,  
Govt. of Assam in the Education Department's letter No. EPG.559/  
87/Pt.-III/87-A, dtd. 15.12.88, No. 559/87/223, dtd. 6.8.89 and  
EPG.559/87/Pt.-III/187, dtd. 6.3.90 as shown in the statement  
enclosed are hereby provisionally approved w.e.f. 25.3.98 or  
there after, as the case may be, against the posts sanctioned vide  
Govt. letter No. B(2)H.553/96/86, dtd. 17.9.98.

As such the appointment of the incumbents holding  
the posts of non-teaching staff as shown in the statement enclosed  
are also provisionally approved w.e.f. 25.3.98 or thereafter, as  
the case may be. They are also entitled to draw the minimum of  
the time scale of pay and other allowances as admissible under  
the rules w.e.f. 25.3.98 or from the date of approval of their  
appointment which-ever is later.

In the aforesaid statement some posts have been shown as vacant as the posts are either actually vacant or the incumbents holding the posts do not possess to present UGC norms. Vacant posts may be filled up after observing all formalities as per UGC guidelines and Departmental procedure & norms. As regards Department's Headship allowances necessary proposal for this purpose with specific resolution of the G.B. including the Head of the Deptt. should be furnished to the D.H.I., Assam for sanction of Headship allowances. In determining the Head of the Deptt., seniority in service be strictly followed; The deptt's having affiliation upto T.D.C. part-II level of GU/DU with prior concurrence of the Govt. will be admissible for Headship allowance, if there are more than one approved teachers posts sanctioned for the subjects which are common to both Arts, Science and Commerce streams as the case may

All the lecturers must fulfill the required conditions as laid down by the UGC for obtaining next higher scale under UGC scheme ~~to due time, otherwise they will be not allowed~~ the above mentioned higher scale during their service period.

It may be noted here that the approval of appointments hereby provisional. As such necessary proposal for formal approval of appointment of all teaching and non-teaching staff as shown in the enclosed statement should invariably be submitted to this Directorate at the earliest along with the undermentioned documents:

- 1) G.B.'s resolution for appointment of the incumbent at the ad-hoc stage of the college.
- 2) G.B.'s resolution for regularisation of the appointment under deficit system of GIA w.e.f. 25.3.98 there after as the case may be.
- 3) Bio-data of the incumbent as per proforma (enclosed)
- 4) All certificate and marksheet of the incumbent attested by a Gazetted Officer from H.S.L.C. onwards
